Annual MPI Reimbursement Rates for Firefighting Costs

ATTENTION: AMM Members

February 23, 2022 – Since 2009, the rates for basic and complex firefighting payments made by Manitoba Public Insurance (MPI) have increased each year on March 1. The increase is based on the prior year's C.P.I. plus 1%.

Effective March 1, 2022, the basic call rate will increase from \$896 to \$935. The complex call rate will increase from \$1197 to \$1249 based on the 2021 Manitoba CPI rate of 3.3% (resulting in a 4.3% increase).



As a reminder, the Claim for Firefighting/Rescue Costs Form is saved to MPI's Partners Website and will be updated annually on March 1st as the rates continue to increase.

Municipalities face multi-million dollar losses due to COVID-19

February 25, 2022 - The Association of Manitoba Municipalities (AMM) today announced the results of a member survey focusing on COVID-19's fiscal impacts on Manitoba municipalities.

According to survey data, municipalities in Manitoba collectively experienced an estimated **\$91.8 million** operating loss in 2021 while an additional **\$53.3 million** shortfall has been forecasted for 2022. Municipalities have also incurred **\$7.3 million** in pandemic-related costs related to staffing needs, purchasing PPE, and enforcing provincial public health orders.

In addition, **89%** of municipalities have experienced further operating losses since the Province of Manitoba flowed \$106 million on behalf of the federal government under the Safe Restart Agreement (SRA) in October 2020. Consequently, **52%** of municipalities indicated that it could take between two to eight years to financially recover to pre-crisis COVID-19 levels.

"It is clear that municipalities continue to experience significant operating shortfalls due to the ongoing pandemic," said AMM President Kam Blight. "While these numbers show a significant financial gap, the figures are actually lower than expected since many municipalities were forced to reduce services given their legal obligation to not run deficits."

The survey was administered in January 2022 and 77 responses were received. The AMM was particularly interested in the financial impacts since 2021 and financial pressures experienced by municipalities overall. The findings will be provided to the provincial and federal governments as they contemplate additional financial assistance to municipalities in their respective budgets.

"Our latest survey continues to show that the largest financial hit to municipalities has been related to operating recreational facilities and other public municipal buildings," added President Blight. "Moving forward, it is vital that all orders of government work together to ensure greater supports are provided so municipalities can continue offering essential services that Manitobans depend on."

Education Funding Review

On November 18, 2021, the Manitoba government announced the establishment of a consultation team, including the AMM, that will guide the development of a new education funding model to ensure funds are invested in a fair and sustainable way.

The AMM has long called on the Province to establish a multi-stakeholder Task Force to comprehensively review and modernize Manitoba's education funding model. We know that the current model is antiquated and inadequate, particularly given the ever-increasing demands and financial pressures on municipalities. Accessibility Legislation and Standards

The Province of Manitoba officially launched the Manitoba Accessibility Fund (MAF) to help municipalities mitigate accessibility barriers throughout local communities.

The MAF, managed by the Winnipeg Foundation, was launched in 2021 with a \$20 million investment. The MAF will offer grants of up to \$50,000 and must target the three accessibility standards under *The Accessibility for Manitobans Act* which include, the customer service standard, employment standard and/or the information and communications standard. The application intake opens **March 1, 2022** and the **deadline to apply is April 15, 2022**.







Exchange Group Completes Independent Review of AMM Insurance Program

March 2, 2022 – Please be advised that the Association of Manitoba Municipalities (AMM) engaged Exchange Group (EXG), a Manitoba-based Chartered Professional Accounting and Consulting Firm, to independently review the Western Financial Group's Property and Casualty Insurance and Employee Benefits Insurance Programs Protected Self-Insurance Programs (PSIP) provided to AMM members.

Overall Satisfaction:

- **94% of Stakeholders** are satisfied/very satisfied with the WFG Property and Casualty Program.
- **90% of Stakeholders** are satisfied/very satisfied with the WFG Employee Benefits program.

The following summarizes some of the Key Findings of the analysis performed:

- **High Level of Member Satisfaction:** Based on the Members interviews and Member Survey results, there is a high level of Member satisfaction with the AMM's Protected Self-Insurance Program.
- **Cross Jurisdictional Review:** Based on the Cross Jurisdictional Review, the AMM's Protected Self-Insurance Program provides the following key values to AMM's Members compared to other Associations' Programs reviewed in Western Canada:
 1. **AMM Greater Control to Stabilize Premium Rates:** Competitive Premium Rates (especially in the Hard Market over the past three years) with the AMM / WFG's program providing greater / full control of Premium Rates compared to the Other Regulated Associations' Programs reviewed who have limited or have no control over the Premium Rates charged to their Members.
 2. **AMM Return of Premiums:** AMM / WFG's program provides a Return of Premiums to Member Municipalities compared to all the Other Associations' Programs reviewed do not provide any Return of Premium to their Members. The Members survey confirmed this is an important value to the AMM Members.
 3. **WFG Commission towards AMM's Operating Costs:** AMM / WFG's program provides an annual WFG Commission towards AMM's operating costs where all the Other Associations' Programs reviewed do not provide a Commission to support their Association's operating costs. The Members survey confirmed this is an important value to the AMM Members.
 4. **AMM Ownership and Control of Pool:** AMM / WFG's program provides AMM with ownership and full control over their Pool fund (and its interest earned) compared to the Other Associations' Programs reviewed that may not own their Pool fund or do not have a Pool Fund at all.
 5. **New Members:** AMM / WFG's program does not require New Municipality Members to make a Capital Contribution to the Pool fund where some of the Other Associations require new municipalities to make a capital contribution to become a Member.
 6. **AMM Programs:** WFG manages all Programs. The unique structure allows WFG in consultation with AMM to adjust % allocation of risk assumed by the AMM held pool and excess insurers. When insurance rates go up, the program can be shifted to increase amounts paid into the AMM owned loss pool rather

than going to insurers. This is compared to Other Associations who manage less Programs than WFG with varying degrees of experience. Majority of Other Associations use a combination of Self-Managed and / or multiple Broker / Insurers.

7. Staff Expertise Requirements: AMM outsources their Insurance Programs to WFG dedicated staff. This eliminates AMM's need for hiring and retaining staff with Insurance Expertise. This is compared to Other Associations' Insurance staffing levels that ranges from one staff (Broker / Insurer Model) to 30 staff who have insurance industry expertise.

8. AMM More Loss Presentation Services: AMM / WFG's program provides more Loss Presentation Services to Member Municipalities and without additional costs compared to the Other Associations' Programs reviewed.

9. AMM Communication to Members: AMM / WFG have more communication methods compared to the Other Associations' Programs reviewed.

I also want to show the dark sides of Canadian history. The things that we don't learn from school and things that we don't hear about in the news.

I do all the research myself, as well as the writing and recording. As a result, it does not take any resources away from the community.


The episode length, depending on content and interviews, would range between 15 minutes and 40 minutes.





In all Canadian provinces, except for Alberta and Manitoba, <23L pesticide and fertilizer containers are collected at ag-retail locations. In Alberta and Manitoba small containers have been collected at municipal collection sites since 1989.

On January 27th, 2022, it was announced that **over the next three years (2022 through 2024), the collection of <23L containers will transition from a municipal collection model to an ag-retail collection model.**

In Spring 2022, ag-retail locations will have the opportunity to begin collecting <23L containers. Cleanfarms' contractors will pick up containers from ag-retailers and municipalities throughout the transition period. By December 31, 2024, all municipal container collection sites will be fully decommissioned. As of January 1, 2025, Alberta and Manitoba ag-retailers will be the central drop-off location for their customers.
